Instructions (for staff & registrant use)

Please ensure **all** applicable fields of the registration form are completed upon registration. Complete and accurate data is integral towards proper record keeping, effective communication with our membership, and the demographics needed for successful grant applications. Please see below for guidance/clarification on each section of the registration form.

PART A – Family Contact Information

- This section should be completed by the person completing the registration form and paying for the membership. Note that this person will be considered the main point of contact for memberships with multiple players (family, couple, etc.). If a junior player is being registered then this should be the player's legal guardian.
- All fields within this section are required. It is also highly encouraged that the registrant adds themselves to our email list as this is the most effective way of staying up-to-date and involved in the on-goings of the Club.

PART B – Player Details

- All players under the membership being registered should be listed here. For example: if registering a family, the payor would list their name first, followed by their spouse/partner (if applicable) and then their children. The last name of each player should be provided unless it is the same as the last name listed in Part A. *Note that if no last name is provided it will be assumed that it is the name listed in Part A.*
- **Please ensure all players U10 are also listed on the registration form despite the fact that there are no membership fees associated with this age category.**
- Gender, Player Category, Birth Date – please circle the applicable and list the birth date of each player. This data contributes to the demographics used when applying for grants which allow the Club to continue to operate and expand.
- Health concerns/Emergency Contact – please list any health concerns of any of the players as well as an emergency contact (name and #) for all players. Providing this information is essential towards the safety our Club.

PART C – Membership Type and Fees

- The type(s) of membership should be selected here based on the players listed in Part B. The quantity of each should be listed and calculated out to the extended column. For example: if a parent is registering 2 juniors the quantity column would indicate "2" and the extended column would indicate "\$240" (2 x \$120). The extended column should then be subtalled to the applicable field.
- Tennis Nova Scotia (TNS) Fee:
 - The TTC is a TNS member club. Member clubs are required to remit \$5 per club member over the age of 9. The quantity should therefore be the # of players listed (excluding U10s) in Part B and the total should be this quantity multiplied by \$5. Example: a family of 4 with 1 junior and 1 U10 is required to pay \$15 (\$5 x 3).
- Completion: the total amount due should equate to the total of all membership fees plus the required TNS fees. The registrant should then select the applicable payment option and remit the total amount due. Staff should complete the "For Internal Use Only" section. The "Additional Comments" field should be used in circumstances where the registration form/instructions above do not encompass pertinent information that should be communicated/kept on record.
